	Motor vehicle dealers who are required to complete this form must submit it with their Dealer's Monthly Sales Report ( <b>Form 385</b> ) if they are not reporting sales online.
	The sale of marinecraft, manufactured homes, or vehicles that have been issued a salvage title or junking certificate or transfers made to licensed vehicle dealers, out-of-state purchasers, insurance companies due to theft or casualty loss, beneficiaries named in a trust, or transfer on death beneficiaries are not required to be reported.
	The seller remains the last titled owner on record until the purchaser titles the vehicle in his or her name. This form may be used in place of a bill of sale, when applying for title on a newly purchased vehicle to obtain a 180-day sales tax credit.
